**NOW THIS DEED OF TRUST WITNESSETH AS
FOLLOWS:**

1. **NAME:** The Trust hereby established shall be named as
“**SWASTIK WELFARE AND EDUCATIONAL
TRUST**”.
2. **PLACE:** Office of the Trust shall be situated at “**SHOP
NO.1,BASEMENT, CHANDRA COMPLEX, SAGUNA

DANAPUR, DIST- PATNA- 801503 (BIHAR) AT
LOCAL OFFICE:- INDRAPURI ROAD NO -1, PO.+PS.
PATLIPUTRA, DIST- PATNA-800013, BIHAR INDIA.or**
at such other place in India as the Trustees may from time to
time think fit.
3. **OBJECTS** The objects for which the Trust is founded are:
- a) To establish, maintain and run Schools, Colleges, Industrial
Training Institutes (ITI), B. Ed Colleges, Paramedical
Centers, Job Training Centers, Skill Development Centers, or
any other educational and vocational institutes.

- b) To organize Health Check-up Camps, Health Welfare Camps, Blood Donation Camps or to organize and provide for any kind of medical relief for all sections of the society particularly for the poor and backward.
- c) To set up hospitals, nursing homes, diagnostic centers and healthcare centers and provide, encourage, initiate or promote facilities for the discovery, improvement or development of new methods of diagnosis, understanding and prevention and treatment of diseases.
- d) To work for the upliftment of the poor and weaker sections of the society and liberate them from social injustice and improve their economic status and obtain them equal place in society.
- e) To work for the eradication of the social evils like dowry system, child marriage, child labour, drugs addictions, untouchability, etc. and to run awareness program in the society.
- f) To render financial and other assistance in any form to the common people in order to enable them to generate income for their livelihood.
- g) To render financial and other assistance in any form to the common people for their betterment and in order to improve their social, physical and mental status, such as assistance for construction of House or Toilets, assistance for Medical Treatment, assistance for Cost of Education etc.
- h) To establish Training Centre, Research Centre and other allied education institutions.
- i) To educate, train and impart educational, vocational training and teachers training programs.

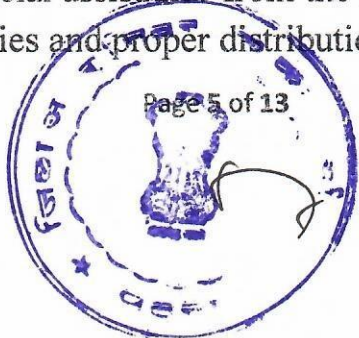


- j) To establish, run and maintain Cultural and Social Institutions.
- k) To open, run and manage rehabilitation center for mentally and physically challenged.
- l) To provide legal services and legal aid to all sections of the society including poor & backwards.
- m) To advance Indian Culture, Traditions and Literature of this Country for the benefit of our Nation.
- n) To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- o) To establish research and training centers for the furtherance of education/learning in its various fields and branches.
- p) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- q) To establish centers for employment generation for all sections of the society particularly for weaker female sections of the society.
- r) To engage in equipment, aid and appliance distribution such as laptops, cycles, wheel chairs, sewing machines, repairing tools, machine kits etc.
- s) To undertake skill development program through public private partnership (PPP) mode
- t) To work for environmental concern & undertake various activities for maintaining a healthy & clean environment.
- u) To receive financial assistance from the other agency in India and other countries and proper distribution of there to.

v) To advance any other objects of general public utility.

The trust shall be an irrevocable public, educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

4. NUMBER OF TRUSTEES:

The number of Trustees including the Author of the Trustees shall not be less than two and not more than seven (7) persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

These Trustees shall hold office for such duration as may be specified by the board of trustees.

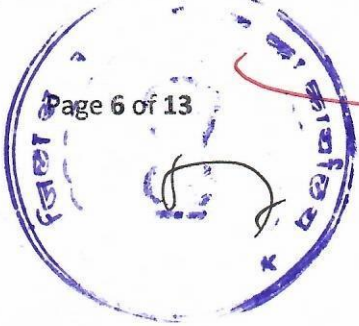
6. MANAGING TRUSTEE:

a. The day-to-day administration of the Trust shall be looked after by the Managing Trustee under the guidance, control and supervision of the Board of Trustees.

- b. The Board of Trustees shall nominate one amongst the trustees as specified in para (4) above to be the Managing Trustee, who shall hold office for such period, as may be decided by the Board of Trustees.
- c. The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.
- d. Provided that the first Managing Trustee of the Trust shall be Raghuvendra Kumar who will hold the chair for the lifetime unless he is disqualified under the Para 8 below.

7. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in para (4) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

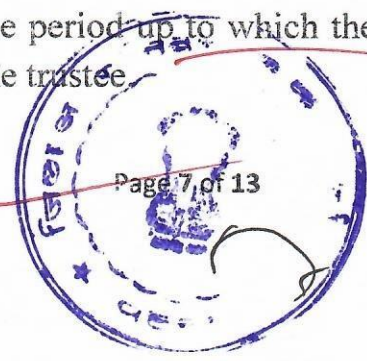
8. TERMINATION OF OFFICE OF THE TRUSTEES:

- iii. if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv. if he has been found guilty of any theft, embezzlement misappropriation of the fund of the Trust.
- v. if he is found to have acted against the interest of the Trust.
- vi. if it is unanimously decided by the Trustees specified in Para (4) above that his continuation in the Office is against the interest of the Trust.

9. MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once in three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

10. NOTICE:

Seven days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

11. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be two numbers. Quorum will not be required for a meeting adjourned for want of Quorum.

A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

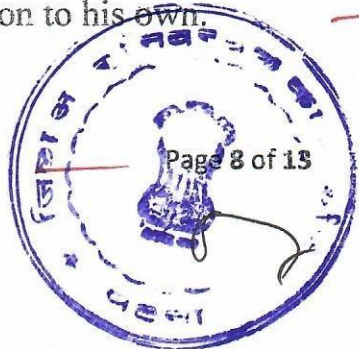
12. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. 13. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

- (a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- (b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:
- i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
 - ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
 - iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
 - iv)(a) To raise loans from nationalize bank or any other financial institution, to receive monies, securities or other movable property on behalf of the Trust.
(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
 - v) To award scholarship and make donations calculated to promote the objects of the Trust.
 - vi)(a) To enter into contracts, or engagements on behalf of the Trust.
(b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.

vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.

ix) To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

x) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.

xi) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.

xii) To frame Bye-Laws and such other regulations as are required for achieving its objectives.

xiii) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely:

(a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.

(b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.

(c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.

- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.

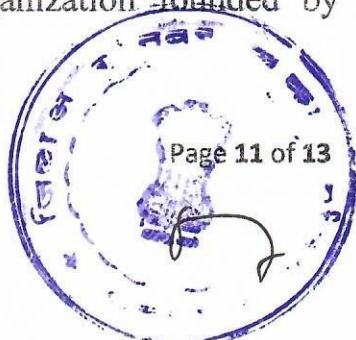

15. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

16. ACCOUNTS:

The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant every year i.e., commencing from 1st April to the 31st March of next year.

17. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

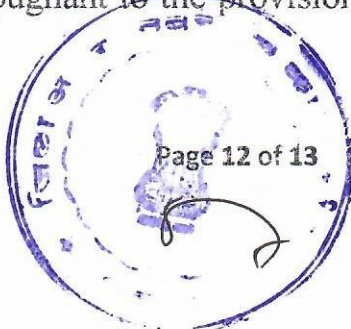
